Application Deadlines:

Matriculation: February 1, 2014 – Priority Consideration

Non-Matriculation: August 1, 2014 – Priority Consideration

Complete applications submitted after the priority consideration deadlines will be considered until programs reach capacity or until the final deadlines (Aug. 1 for fall matriculation and Aug. 15 for fall non-matriculation).*

*Matriculation applications for Counselor Education (MA or SAC) programs will only be considered if submitted by the February 1st deadline. International applicants needing a student visa must apply by February 1st for summer/fall matriculation. MAT Secondary Education requires a Summer start and must apply by February 1st (for priority consideration or by the final deadline of May 1st.

Financial Information:

Students pursing a graduate degree or certificate at TCNJ may be eligible for some type of student financial assistance, including, but not limited to, student loans and assistantships. Graduate students must follow the same procedures as undergraduates in applying for federal loan assistance. Students who have not yet matriculated into their program of study are not eligible to receive federal or TCNJ funding. Graduate students must be enrolled in at least five (5) credit hours at the 500 level or above in order to be eligible for student loan assistance, and for TCNJ to certify enrollment for a loan repayment deferment.
